## HOW TO USE

AREA	PEST CONTROLLED	RATE	HOW TO APPLY
In and around the home and garden	Cockroaches, Spiders	Spray: 10mL in 1L water	Apply to cracks, crevices, harbourages, eaves, down pipes and other places where pests may occur.
	Ants Argentine ants		
Lawns	Lawn armyworm, Lawn grub, Lawn Beetle	Spray: 7mL in 2L water, apply over 10 square metres	Spray over total lawn area when pests are present. When pests are moving, treat a strip in advance of the infestation. Apply follow-up treatments as required.
	African black beetle	Spray: 60mL in 2L water, apply over 10 square metres. Watering can: 60mL in 5L water, apply over 10 square metres	Apply to lawn when pests appear. Water immediately after application

### HOW TO PREPARE

Product mixes easily with clean water. Using a measuring device add the required quantity to a clean container.

Do not mix more than is needed. Wash sprayer thoroughly after use.

### CAUTION

DO NOT spray directly on humans, pets, exposed food, food preparation areas or food utensils.  
DO NOT spray if bees are feeding on flowering plants. Will kill bees.

### PRECAUTIONS

**DO NOT APPLY INSIDE BUILDINGS EXCEPT AS A CRACK AND CREVICE TREATMENT.**  
**DO NOT APPLY TO SURFACE AREAS SUCH AS INTERIOR FLOORS OR WALLS.** *WALLS,*

### STORAGE AND DISPOSAL

Store in the closed original container in a cool, dry place out of the reach of children. Do not store in direct sunlight. Dispose of empty container by wrapping in paper, placing in a plastic bag and putting into the garbage.

### SAFETY DIRECTIONS

Harmful if swallowed. Will damage eyes. Will irritate the nose, throat and skin. Repeated minor exposure may have a cumulative poisoning effect. Avoid contact with eyes and skin. Do not inhale vapour. When opening the container and preparing the spray wear cotton overalls buttoned to the neck and wrist (or equivalent clothing) and goggles. If product on skin, wash immediately with soap and water. If product in eyes, wash out immediately with water. Wash hand after use. After each days use wash goggles and contaminated clothing.

### **FIRST AID**

If poisoning occurs, contact a doctor or Poisons Information Centre ( Phone: 131126). If swallowed, do not induce vomiting. Give a glass of water. If swallowed, give one atropine tablet every 5 minutes until dryness of the mouth occurs – if poisoned by skin absorption or through lungs, remove any contaminated clothing, wash skin thoroughly and give atropine tablets as above. Get to a doctor or hospital quickly. If in eyes, hold eyes open, flood with water for at least 15 minutes and see a doctor.
